WHEREAS the settler has been having an earnest desire to serve the mankind in general and people of India in particular by creating a charitable Trust out of the money which he seized and possessed of and which has set a part of the purpose as detailed in the Object Clause




WHEREAS The settler has constituted a sum of Rs. 10000/- (Rupees Ten Thousand only) as initial corpus of the Trust Fund together with all the contributions, additions, accumulations and investment in which the same may from time to time be invested, all other movable and immovable properties and assets that may from time to time be vested in the Trustees or be received by them by way of donation or otherwise acquired by them or may come into their hands by virtue of these presents or by operation of law or otherwise howsoever in relation to the Trust hereby created.

AND WHEREAS with a view to and for the purpose of constituting the Trust permanently as an irrecoverable Trust for the purpose of carrying on the Objects of this DEED OF TRUST, it is considered desirable that for purpose for this charitable Trust being on non political and non profit making Institute, the declaration of Trust should be made in the manner set out hereunder.

Now therefore this Deed of Trust Witnesseth as under

1. The settler record and confirm having paid over, transferred and assigned unto the Trustees the said sum of Rs.10000/- (Rupees Ten Thousand only) and all the beneficial interest therein and the income thereof upon the Trust and all for the purpose hereinafter declared of and concerning the same. The Trustees hereby covenant with the settler, his heirs, executors and administrators that they, the Trustees and other Trustees for the time being of these presents shall stand and be possessed of the said sum of Rs. 10000/- (Rupees Ten Thousand only) and all other funds, moneys and properties as may hereinafter by any other person(s) be transferred, assigned or received by the Trustees by the virtue of these presents or by operation of law either by way of endowments, gifts, income, rent, interest, dividends or otherwise whatsoever and all properties, securities, stocks, shares, debentures and investments representing the same (all of which are hereinafter referred to as "Trust Fund") upon trusts and subjects to the powers, provisions, agreements, declarations hereinafter declared and contained and concerning the same.
2. The Trust shall be known as **AHSAN GROUP TRUST**. This name shall not be variable at any time in future.
3. That the office of the Trust shall be situated at Village Salempur Nawada, Delhi Road, NH-24, Tehsil & District Amhora (U. P.) or at such other place as may be decided by the Trustees. The activities of the Trust will be carried out PAN India.
4. The Objects of the Trust are as follows:



- a. To establish, run and maintain Schools, Colleges, Universities, Medial & Dental Colleges, Engineering Colleges, Sports Centers & Colleges, Management & Technical Institutes, Pathshalas, Madarsas, Libraries, Reading Rooms, Hostels, Boarding Houses for use of students and the staff and also generally for the development and/or advancement of education and diffusion of knowledge amongst the public in general and specially for poor.
- b. To acquire, establish, run and maintain Para-Medical Colleges, Institutes, Centers including Hospitals, Clinics, Dispensaries, Maternity Homes, Old Age Homes, Aftercare Clinics, Child Welfare Centers, Parks, Health Check-up Camps and activities, Deaf & Dumb Schools and Centers, Orphanages, Widow homes, Rest Houses, Welfare & family planning & Health Centers, Sanitariums, Laboratories etc.
- c. To promote higher studies and research in science, Medical, Engineering, Arts, Commerce, History, Social Science, Management Education including Computer Science & Education in all its fields and branches and learning in all branches of Studies and Education.
- d. To provide Education, higher Studies, Scholarships, Professional Education and research facilities to poor and needy students to grant studentships and other kinds of aid to poor/needy, deserving students for higher studies and research facilities, including supply of books, food clothes, School & College fees and other monetary assistance specially to poor/needy boys and girls.
- e. To give subscription, donations or contribution to Hospitals, Dispensaries, Nursing Homes, Institutions/establishments or persons carrying on such work and to public charitable Trusts, Institution or Societies.
- f. To provide Medical treatment to poor and needy free and/or at concessional/subsidized rates, orphans, widows and otherwise, including cash donations.
- g. To provide relief during natural calamities such as Famine, Drought, Pandemic, earthquake, Fire, Cyclone, Riots, War and other occasions of calamities of similar nature and to give donations, subscription and contribution to establishments/ persons carrying on such work.
- h. To establish, run maintain and support to poor and diseased providing medicines, living facilities, food, shelter, clothing and other necessities of life.

- i. To acquire/provide/purchase/take on lease/hire Land, Building & constructed Houses/Flats/small tenements, etc. and donate the same to the weaker section/poor and deserving people who do not have necessary shelter/could not afford to purchase/pay rent, free of cost, below cost or as may be desired at the discretion of the Trustees of Trust.
 - j. To open, find, establish, finance, assist and contribute to institutions, commercial, technical or institutions imparting education in workmanship and for providing employment and means of earning adequate wages for the unemployed and needy people from the general public.
5. The Governing Body of Trust shall-
- a. Received the income of the Trust Fund and all other income arising under the deed and there from in the first instance, reimburse, pay and discharge all the cost, charges and expenses which may be incurred in and about the Administration and Management of the Trust of these presents including payment of all taxes and levies on Trustees or the Trust Fund all outgoing, including municipal or other taxes, duties cesses, levies and cost of repairs, preservation, upkeep and maintenance of moveable/immovable property if any forming part of the Trust Fund.
 - b. For the purpose of carrying out the objects of the Trust and for providing the facilities and undertaking the activities as mentioned in clause 4 above be entitled to:
 - (I) Acquire by purchase, grant, and gift or otherwise properties, equipment's and effects of all kinds as they may deem proper.
 - (II) Collect funds and received donations, subscriptions, contributions, grants and gifts in cash or kind and to take loans and advances with or without interest.
 - (III) Accept any kind of donation /Subsidy/ Loan/ Contributions/Advances with or without interest in foreign currency from any institution or person living abroad.
 - c. Hold net balance or surplus of the income of the Trust Fund and corpus of the Trust Fund for the objects of the trust as mentioned in clause 4 above and to be applied in any manner at the absolute discretion of the Governing body of Trustees from time to time.
 - d. Have full power and absolute authorities to add or introduce other specific public charitable objects not inconsistent with the objects and purposes of these presents according to the advancements of

time and circumstances which may exist from time to time as they may consider desirable and in that case such newly added objects so decided upon by the trustees shall be deemed to have been incorporated in the objects of these presents.

e. If the income of the Trust und shall not be sufficient to meet the expenses mentioned in sub-clause (a) above, be entitled to utilize the corpus of the Trust in such a manner as they shall in their absolute direction considering the necessities of the Trust, deem fit and proper.

f. Be entitled to sell, transer, let on hire or otherwise dispose of land deal with any of the moveable/immovable properties forming part of the Trust Fund at such time or times and upon such terms and conditins as they may deem fit and proper. At the present time the Trust has no moveable/immovable property.

g. Have power, keeping in view the necessities of the Trust, to invest the Trust Fund and its income as may not be immediately required for the purpose of carrying out the objects of the trust, any moveable or immovable properties, securities, stocks, shares, debentures of any company, Government securities, or deposits in scheduled Bank/Banks and co-operative Bank/Banks or limited companies as the Trustees may in their absolute discretion deem fit and proper that pwoer to Trustees to vary or transpose such investment from time to time for or into others of any nature whatsoever.

h. If any any time hereinafter it is held that any of the objects or purposes towards which the said income or any part thereof is directed to be applied or extended is not strictly public charitable objects or purposes according to law, then in that case, the Trustees shall apply and expend the said income or corpus towards the executionand carrying out all such of the such objects and purposes aforesaid as may be held to be strictly public charitable public objects according to law.

i. Have all such powers and perform all such functions as are necessary or proper for achievements or furtherance of the objects of the Trust.

6. The number of Trustees shall not be less than three and not more than eleven.

Lineal male descendants of Mohd.Asad Shamsi, Mohd.Athar Shamsi, and Mohd. Awwab Shamsi shall become trustee automatically on attaining age of majority. This shall be subject to vacancy available.

The Governing Body consists of five Trustees as under:-

- I. Mohd. Iqbal Shamsi Managing Trustee/President
S/o Late Haji Mohd. Ahsan

- II. Tariq Ullah Khan Secretary
S/o Late Rauf Ullah Khan
R/o Near Jama Masjid, Kote West,
Sambhal (U. P.)
- III. Mohd. Asad Shamsi Counselor
S/o Mohd. Iqbal Shamsi
R/o Tavela Street, Moradabad (U. P.)
- IV. Mohd. Awwab Shamsi Counselor
S/o Mohd. Iqbal Shamsi,
R/o Tavela Street, Moradabad (U. P.)
- V. Mohd. Abaan Shamsi Counselor
S/o Mohd. Asad Shamsi,
R/o Tavela Street, Moradabad (U. P.)

7. The Governing body shall act for a period of five years from the date of election & further new governing body other than Managing Trustee/President shall be elected in the annual general meeting of the trustees by an election.

a. Causal vacancy in governing body of trust shall be filled in the governing body meeting by appointment up to the unexpired term of trustee.

b. Trustee shall be removed on death/tendency of resignation in writing, keeping himself away from three consecutive meetings on going contrary objects of trust affairs on becoming of unsound mind or incapable due to superannuation or otherwise prosecuted by the competent court. If any trustee causes any kind of nuisance to the Trust affairs, he can be expelled from Trust through voting by 2/3rd majority of Trustees existing at that time.

8. The Trustee Mohd. Iqbal Shamsi shall be the Managing Trustee for life and shall be responsible for normal administration and management of the Trust properties and may delegate or assign such powers and functions to any other Trustee as he may deem necessary or expedient for time being and can withdraw such delegated powers at any time without assigning any reason.

9. In event of death of Mohd. Iqbal Shamsi, Managing Trustee, or desire to retire unfit, incapable to act or otherwise, Mohd Asad Shamsi shall become automatically become managing Trustee. After Mohd Asad Shamsi, Mohd Athar Shamsi shall become automatically Managing Trustee and after Mohd Athar Shamsi Mohd Awwab Shamsi shall become automatically Managing Trustee thereafter lineal male descendants of Mohd. Asad Shamsi, Mohd Athar Shamsi and Mohd Awwab Shamsi shall be appointed Managing Trustee in the sequence followed above.
10. The Trustees may from time to time open and maintain in the name of Trust any banking account or accounts with such schedule Bank/Banks, Co-operative Bank/Banks as may from time to time be determined by the Trustees and forth with pay or caused to be paid the rents, in case profit dividends and all other moneys forming part of the Trust Fund to the credit of any such account or accounts. Such accounts may be operated by joint signature of any three Trustees one of them must be the Managing Trustee.
11. The Governing Body of Trustees shall meet at least once in every three months for the conduction the general affairs of the Trust and may adjourn and otherwise regulate their meetings, proceedings, and procedures, as they think fit. A seven days' notice in advance will be necessary to call the Governing Body and General Meeting of Trustees.
12. Two Third Trustees, of which one will be the Managing Trustee, shall be quorum for a meeting of the Trustees.
13. The Managing Trustee shall have the power appear in all legal proceedings, appoint Attorneys, Advocates, execute promissory notes, bonds, to all such acts that may be necessary to efficiently manage and administer the Trust Fund, delegate duties and functions to any of the Trustees. All the acts, deeds and things lawfully done by the managing Trustee or Trustees by virtue of this shall be binding on the Trust.
14. All questions arising at a meeting of the Trustees shall be decided by majority votes of the Trustees present and voting there at and in case of any equality of votes the Chairman of the meeting shall have a second or a casting vote.
15. A meeting of the trustees at which a quorum is present shall be competent to exercise all or any of the powers, authorities, and discretion vested and exercisable by Trustees under or by virtue of these presents.

16. The Trustees shall keep & maintain proper records, books of accounts in respect of all sums of money received and spent by the Trustees and the matters in respect of which the receipt and expenditure take place and of all assets and liabilities of the Trust.
17. The Trustees shall get the accounts of the Trust duly audited by a firm of Chartered Accountants. The said Accountant shall be appointed every year in general meeting of Trustees. The remuneration of the auditors shall be settled by the Trustees in a meeting mutually in consultation with the auditors.
18. The financial year of the Trust shall close on 31st March every year and its annual accounts shall be prepared & close on 31st March every year.
19. Any property/assets, investments of or for the Trust should be taken in the name of the trust or alternatively kept in the name of at least two trustees.
20. All deeds, documents, agreements of whatsoever nature relating to or affecting the properties, contracts or affairs of the Trust shall be executed by the Managing Trustee or at least two Trustees.
21. So often as new Trustee or Trustees shall be appointed, the Trust Fund or the Trust properties for the time being shall become vested in the new Trustee or Trustees jointly with the existing or continuing Trustee or Trustees and every new Trustee shall have the same powers, authorities and discretion and shall in all respect act as if he had been originally appointed as a Trustee under these presents.
22. The Trustee shall be entitled to frame rules and regulations for the administration of the trust and for carrying out its objects and to alter, amend and/or vary such rules and regulations from time to time as they may deem proper.
23. The trustees shall have full powers to institute, defend and conduct compromise or compound all actions, suits and proceedings and all differences, claims and demands and to refer any dispute and difference to arbitration and to adjust, settle and approve all accounts or transactions relating to the Trust & Trust Fund.
24. In connection with the administration of the Trust and management of the Trust properties and for carrying out its object the Managing Trustee shall be entitled to appoint such employees, agents, contractors, solicitors, advocates and other persons upon such terms and conditions as he may deem proper, to determine the function and duties of the employees and agents, to suspend, remove or

dismiss any such employees and to make provision for the benefit for the employees by way of Provident Fund, Gratuity or otherwise as the trustees may deem proper.

25. The Managing Trustee shall be entitled to receive any money or properties in respect of or to the account of Trust Fund or that may be payable to or receivable by the Trustees and to give receipts and effectual discharge for the same.

26. The Trustees for the time being under these presents shall be respectively chargeable only for such moneys as they shall respectively actually receive notwithstanding their respectively signing any receipt or receipts for the same of conformity and shall be answerable and accountable only for their own acts, receipts neglects or defaults and not for those of the others or other of them or for any Banker or other person with whom or into whose hands any Trust money or investments be deposited or come or for any loss unless they shall happen through their own willful default respectively.

27. The Trustees or Trustee for the time being may reimburse themselves or himself or pay and discharge out of the Trust Fund all expenses properly incurred to or about the execution of the Trust or powers under these presents and shall be indemnified out of the Trust Fund against all liabilities, loses, damages, costs, charges and expenses incurred in or about the execution of the Trust or powers under these presents.

28. IT IS HEREBY FURTHER AGREED AND DECLARED : that in all matters wherein the Trustees have a discretionary power or wherein there shall be difference of opinion regarding the construction of these presents or the management of the Trust Fund or any part thereof or the execution of any of the Trusts or powers of these presents or if the Trustee shall be equally divided in opinion, the matter shall be decided according to the vote of majority of the Trustees for the time being in voting the matter which shall be binding on the minority as well as on Trustees who may not have voted. In case the Trustees so voting is equally divided in their opinion, the chairmen of the meeting shall have the second or casting vote.

29. It shall be lawful for the Trustees to settle or determine whether any money accruing due from any shares or securities or other funds forming part of the trust Fund are or shall be considered for the purpose of these presents as capital or income and whether out of capital or income any expenses, outgoing and losses should or ought to be paid and otherwise to determine all matter and

efficiency, doubt and dispute and all questions arising in the course of or incidental to the execution of the trusts or powers of these presents and any such settlement or determination on the part of the Trustees or any act or conduct on their part implying such settlement or determination although the question involved may not have been raised shall be conclusive and binding.

30. IT IS HEREBY FURTHER AGREED AND DECLARED: that if on the winding up or dissolution of the trust there shall remain after the satisfaction of its debts and liabilities, and property whatsoever, the same shall not be paid to or distributed among the Trustees or any of them but shall consistently with the objects of the Trust be dealt *with in such manner as the Trustees may determine or be given to* some other charitable Trust having similar aims and objects.

31. Subject to provisions herein contained, this Trust Deed shall be read construed as part of the Original Trust Deed Registered in Book No. 4 Volume No. 68 Page No. 269 to 286 serial No. 311-312 dated 25-10-2000 registered with Sub-Registrar-I Moradabad and Supplementary Trust deed registered in Book No. 4 Volume No. 218 Page No. 119 to 142 Serial No. 177 dated 25/06/2010 registered with Sub-Registrar-II Moradabad and unless the context otherwise requires, the Original Trust Deed shall remain in force and shall be binding on Trustees.

IT IS HEREBY FURTHER AGREED AND DECLARED FOR SCHOOL:

32. The Registered Society of the school will be renewed from time to time.

33. There will be a member nominated by Education Director in the managing committee of the college.

34. At least 10% seats of the college will be reserved for the meritorious students belonging to schedule casts and schedule tribes and the fees will not be charged more than the schools recognize by Madhyamik Shiksha Parishad, U. P.

35. If the institution is recognized by the I.C.S.E /C.B.S.E. Board and the recognition by U. P. Board or aid by Government will be finished.

36. The Teachers and other staff members will get the salary and other benefits according to the Government rules

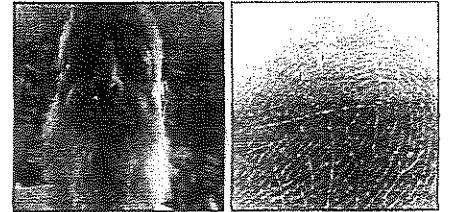


37. The service rules will be made and all the benefits of service will be provided to the workers according to Non-Governmental colleges and the workers will get the pension.

40. There should be no change amendment in the above rules and instructions without the permission of State Government.

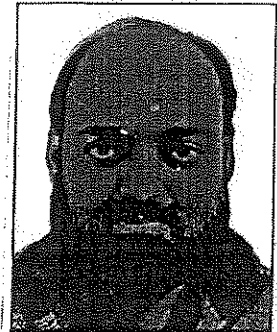
