13. To make Rules of the Trust by two-thirds majority, and to amend such rules and regulations by two-thirds majority.
14. There shall be special meetings of the Trust by passing resolutions as and when necessary by the Board of Trustees or by written request of one-third of the members of the Trust.
15. Notice of every Board of Trustees meeting specifying the date, time and place of the meeting together with the agenda shall be sent to the each of Trustee by means of post or hand well before to such meetings.
16. All activities/proceedings discussed or decided at the Board of Trustees meetings shall be recorded in the proceedings or minute books, which shall be signed by the president/Secretary and Board of Trust Members.
17. Trustee who present at the time of meeting are only entitled to voice and vote.
18. More than fifty percent of the total members at a given time shall be the quorum for the meeting within an hour from the time appointed for the meeting. Of quorum is not found, the
